

2016/17 TREASURERS REPORT 1.

1.1 OVERVIEW

The NZ Arb Executive Committee is pleased to present this Treasurer's Report. Also attached is the Annual Financial Report that has been prepared by our accountants, Mc Coy and Co, for the year ending 31st of March 2017(Appendix 1). The information supplied below summarises the financial position of the Association and the NZ Arb Executive's management of our accounts during 2016/17 including our plans for the future.

Firstly I would like to apologise for the later than usual Treasurer's report for the 2016/17 financial period. The initial Annual Financial Report supplied by McCoy and associates recorded a loss in the 2016/17 financial period due to a new interpretation of which areas of income were eligible for tax. This is discussed further in section 1.3.

2016/17 saw the Association membership numbers continue to grow by 6%. The Executive with the assistance of On-Cue have created new in depth budgets to carefully track the spending of the Executive and the various subcommittees. This combined with more detailed coding of expenses will give us accurate tracking of our Income and Expenditure to date and moving forward.

Our Proposed Draft 2017/18 Budget is based on expenditure from 2016/17. The major additional expenditures are in the creation of a "Marketing" sub-committee and the redevelopment of the website. Please see section 2.2.3 for detail. We have predicted conservative achievable gains in membership and other areas of revenue.

Thanks, need to be made to our members and sponsors, without your continued support NZ Arb could not exist.

1.2 FINANCIAL POLICY

The NZ Arb Executive has committed to a minimum \$100,000.00 cash reserve figure; this has been retained over the 2016/17 financial year and will continue for the 2017/18 financial year. This reserve is kept in two staggered long term deposit accounts. The use of two accounts minimises the risk of losing the interest gained to date in a break fee if the Association is ever required to access the accounts.

1.3 INCOME TAX INTERPRETATION

We were presented with our annual financial report by McCoy and associates later than expected. This report included an Income Tax bill of \$11,908.00 resulting in a loss of -\$8619.00. This level of taxation was a huge deviation from the norm (roughly a 1000% increase on the previous year) and turned a strong financial year into a loss.

The Committee immediately began to query the figures from McCoy and associates. Through lengthy correspondence we learned that they had chosen to apply a different interpretation of IRD policy as to what is considered taxable income. We were immediately concerned; firstly, that if they were correct in their interpretation that we had some potential historical liability to IRD or secondly that through a modern policy change we had incurred a loss on the Associations behalf.

After a long and drawn out attempt to clarify the change, the Committee was forced to enlist Crowe Howarth (a large international firm with over 23 offices in NZ) to audit the McCoy interpretation and advise how NZ ARB should proceed.

The advice received from Crowe Howarth reported a taxable income of \$2,946 and to instruct McCoy and associates to apply the historical methodology.

My understanding is that McCoy and associates new point of contact did not fully understand or research our various incomes and their purpose which ruled them as eligible in their eyes for taxation. Furthermore, McCoy could not provide a concrete explanation for the change other than it was their opinion. They could not clarify nor provide any evidence as to which interpretation was correct. Crowe Howarth merely researched the nature of the income in detail to clarify that it was not liable for taxation.

1.4.1 INCOME NOTES

- 1. We were unable to register any donations this financial period.
- 4. Strong gains in ISA sales.
- 5. Strong gains in ISA subscriptions
- 7. The higher costs involved in hosting the conference in Auckland caused the difference between budgeted and actual.
- 10. The increase in tree climbing competition income was due to more climbers and late payments received
- 11. The decrease in tree climbing sponsorship was due to a withdrawal of Asplundh's Cornerstone sponsorship and no NAOTY sponsors
- 12. The TRAQ course broke even as intended not all income is shown in this financial year.
- 13. This increase does not reflect the hard work put in by the sponsorship committee. The loss of major cornerstone sponsors was offset by the recruitment of new sponsors in other areas.
- We issued one less copy of Tree Matters this period due to the restructure, change in designers and editors, this resulted in the drop in advertising income.

Income and Expenditure summary

The NZ Arb Association tracked strongly in most areas of Income and Expenditure with the accuracies in the new coding accounting for some discrepancies in budgeted income and expenses vs the actual figures. Careful spending accounted for our other

Income fluctuation over the financial year and longer term is an issue when balancing the NZ Arb yearly budgets. An example of this is the TRAQ course, it currently shows a loss due to payments falling outside the financial year despite breaking even as planned. This also applies to ISA travel refunds which were payed outside the 2016/17 financial year.

1.5.1 EXPENDITURE NOTES

- 20. The Committee purchased t-shirts, a tent, stand and table including flyers to establish Ask an Arborist.
- 26. This was contributed to Andrew Benson's research into Root Pruning.
- 30. Marketing and advertising spend was allocated to the Ask an Arborist project
- 31. Frugal exec behaviour resulted in a strong gain.
- 32. This included the donation to the battle to save the Christchurch trees.
- 34. This area had not been included in the budget but is now reflected as per the Crowe Howarth figures.
- 40. This is a late invoice claim for travel that took place in the previous period.
- 45. The Approved Contractor Status(ACS) generated a higher than normal cost this year due to the assessment of 14 companies. After the initial expense of an assessment NZ Arb makes a marginal profit over the five year term of a companies approved status, through their membership fee. A discussion will be had with the ACS subcommittee on the pricing and auditing structure to try and improve the regularity of the cashflow in the future. The addition of three new ACS members and nine returning members was seen as an overall success for the status.
- 47. (and 48.) The discrepancies are a result of coding changes.
- 49. The TRAQ course broke even as intended not all income is shown in this financial year.
- 51. Tree Matters spend was lower due to the omission of one addition.
- A change in email hosting is reflected in this cost and NZ Arb taking ownership of domains and hosting server.
- New Arborist of the Year expenses are now coded under the Tree Climbing Expenses 54

March 2017, the NZ Arb financial activity resulted in a net gain between Income and

2. 2017 TREASURER'S STRATEGY

2.1 BUDGET EXPLANATION

In setting the budget for 2017/18, the executive is keen to invest in three key areas for the benefit of the membership. These three main investments in the 2017/18 budget as well as some smaller however no less important projects have been included to continue the progression of our industry.

- Firstly, the creation of the marketing sub-committee to advance the publics knowledge of Arboriculture in New Zealand.
- Secondly, the creation of a dynamic new website to improve usability, increase traffic and therefore advertising
- Lastly, the continuation of our Ask an Arborist project which has already received praise for its work in educating the public and expanding on the great experience had at NZ Arb events.

- 21. The increase in expenditure for the Business Executive Officer is a direct result of increased tasks from subcommittees and marketing, the rise in income offsets this.
- 28. We think NZ Arb should take a more active role in the promotion of the industry. The NZ Arb executive proposes the creation of a marketing sub-committee with a budget of \$15,000 tasked with giving NZ Arb a voice during media events such as the tree failure in the Auckland Creche. The Committee will also serve as the sole point of contact for Media interaction in general, promoting a single strong message to advance our core goal of educating the public to the value of trees and the importance of using qualified Arborists for their care.
- 38. ISA covers the costs of travel for the CoR Chair and one executive officer.
- 45. The increase in Tree Climbing Competition Expenses includes the New Arborist of the Year Expenses, Rural Games and late invoices received for costs that were incurred during the previous financial year.

2.5 LEVEL OF RISK

The level of risk in the 2017/18 budget is acceptable as a small surplus is forecast. Our increases in Income have been estimated in a conservative fashion and additional spending kept at affordable levels. The Cash reserve (as mentioned in 1.2) remains above the minimum \$100,000.00 therefore the level of risk is seen as acceptable by the current executive.

2.6 TREASURERS SUMMARY

The unheralded change in Income Tax calculation by McCoy and associates was extremely frustrating and required considerable Executive resource to resolve. This drawn out process resulted in the delayed report and was not how I had intended my first year as Treasurer to end. Moving forward it is the Executives intention to obtain the services of a new Accountant familiar with not for profit organisations to ensure this does not happen again.

NZ Arb tracked strongly with increases in sponsorship and subscriptions. Frugal spending and cost cutting in other areas allowed us to tackle new projects or improve on current ones without making a Loss. Our strongest sources of income by far are the Conference, Sponsorship and Membership subscriptions. We feel we need to continue to focus Association resources on strengthening these avenues and ensuring their continued success. Additional resources can be put into creating new revenue streams such as advertising but we need to safeguard our biggest earners and ensure the quality of product remains high. A switch in sponsorship strategy from targeting major players within the industry to our external suppliers looks to be the future in the current environment. On this note could Association members please examine their outgoings and contact the sponsorship committee with suggestions and contacts.

As an Executive we plan to continue to spend in area's which further our Mission Statement to encourage, foster, improve and educate in all aspects of arboriculture throughout New Zealand.
